- 1.2 By submitting your application you are explicitly committed to participating in the Art-Thessaloniki Fair, if you are selected.
- 1.3 The Application must be submitted electronically via the Art-Thessaloniki Fair website no later than the end of the applications.
- 1.4 Only the Applications containing all the required information and the Additional Application Material will be examined by the Selection Committee.

2. STAND
