## TERMS AND CONDITIONS OF PARTICIPATION

### 1. APPLICATION – NOTICE OF ACCEPTANCE

- 1.1 These Terms and Conditions apply only upon acceptance of the Exhibitor's request by the Art-Thessaloniki Fair Selection Committee. In case of acceptance, the terms and conditions will apply immediately for the entire period of the exhibitor's participation in the Art Fair. The notification of acceptance or rejection of the application will be notified to you immediately.
- 1.2 Galleries with their own exhibition space and continuous exhibition activity for the last two years are eligible to submit the application form.
- 1.3 Galleries that are active for less than 2 years are only eligible to submit an application form for a booth up to 30m<sup>2</sup>.
- 1.4 By submitting the Application, the gallery is explicitly committed to its participation in the Art-Thessaloniki Fair, if selected.
- 1.5 The Application must be submitted and sent electronically through the Art-Thessaloniki Fair website, no later than the end of the applications deadline.
- 1.6 Only Applications that contain all the required information and the corresponding accompanying material will be examined by the Evaluation Committee.

## 2. STAND

2.1 The Exhibitor has the possibility to request a different size of booth from the proposed ones, but the Organizer does not guarantee its concession in case of unavailability of space.

2.2 After the submission of the Application, the Exhibitor does not have the possibility to change the size of the stand.

2.3 After accepting participation, the Organizer reserves the right to change the size of the stand for practical reasons, after informing the Exhibitor.

2.4 The location of the booths is the responsibility of the Organizer.

2.5 The cost of the booth includes:

Booth construction (3 or 4 wooden surfaces 3m high in white color), Basic LED booth lighting, Electricity supply 240W, General exterior wall LED lighting, 24-hour security, public areas cleaning, Free parking, Wireless internet connection, Registration in the exhibition catalogue, 5 free catalogues, 10 opening invitations, 5 free entrance cards.

2.6 The charge for each additional entrance card or VIP invitation will be +10€.

2.7 The removal of the artworks from the exhibition booths should take place at the end of the exhibition, after 10:00 p.m.
