#### 1. APPLICATION – NOTICE OF ACCEPTANCE

These Terms and Conditions become effective only upon late acceptance of the Exhibitor's application. In such case of acceptance, the terms and conditions will be immediately in effect through the entire term of Exhibitor's participation in the Fair. The notification of acceptance or rejection of the application will be notified to you immediately.

- 1.1 Projects entitled to apply are those with their own exhibition space and continuous exhibition activity through time.
- 1.2 By submitting their Application, the Projects, if selected, are expressly bound to participate in Art-Thessaloniki Fair.
- 1.3 The Application must be submitted electronically through the Art-Thessaloniki Fair website until the deadline for the applications.
- 1.4 Only the Applications containing all the required information and the Additional Application Material will be examined by the Selection Board.

#### 2. STAND

- 2.1 The Organizer is responsible for positioning the stands at the exhibition area.
- 2.2 The booth cost includes: booth construction (3 wooden surfaces 3m high -white color-), Basic booth LED lighting. 240W power supply. Basic exterior wall LED lighting (1 LED/. 24-hour security. Free parking. Cleaning of common areas. Wireless internet connection. Entry in the exhibition catalogue.
